Decision VI/28: Multi-year programme of work of the Conference of the Parties up to 2010

Dear Madam/Sir,

The Secretariat of the Convention on Biological Diversity (SCBD) has the honour to inform Parties and governments that, following consultation with the Bureau and in accordance with decision VI/28, paragraph 3, of the Conference of the Parties, the Open-ended Inter-sessional Meeting on the Multi-year Programme of Work of the Conference of the Parties up to 2010 (MYPOW) will be held from 17 to 19 March 2003, at the International Civil Aviation Organization Conference Center, Montreal, Canada.

The Open-ended Inter-sessional Meeting on the Multi-year Programme of Work of the Conference of the Parties up to 2010 will be held back-to-back with the eighth meeting of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA) as provided for in decision VI/28. However, taking into consideration the provisional agenda for the meeting, including the need to review the outcome of the World Summit on Sustainable Development and its potential impact on the work programme of the Convention, it was felt that the meeting should extend over a three-day period instead of two days as originally envisaged.

The provisional agenda for the meeting is attached for your information. Other pre-session documents will be made available in due course. In this connection, Parties and governments are reminded that proposals on issues to be included in the multi-year programme of work for the Conference of the Parties up to 2010 should be communicated to the Secretariat by 31 October 2002 (please refer to notification 2002-056 of 3 July 2002).


