 - <u>Important to all delegates</u>: In line with other UN meetings, each delegate will need to upload a copy of their passport bio-page and complete the "personal data" section on the Kronos registration system, as part of the online registration process for the meetings.

Governments, as well as organizations accredited to CBD meetings (please refer to notification 2024-038 for accreditation process for organizations), who wish to organize side-events are kindly requested to submit their request within the above timeframe. Preference and priority will be given to side-events convened by multiple partners hosting the side-event and requests may be limited or reduced depending on the slots available.
